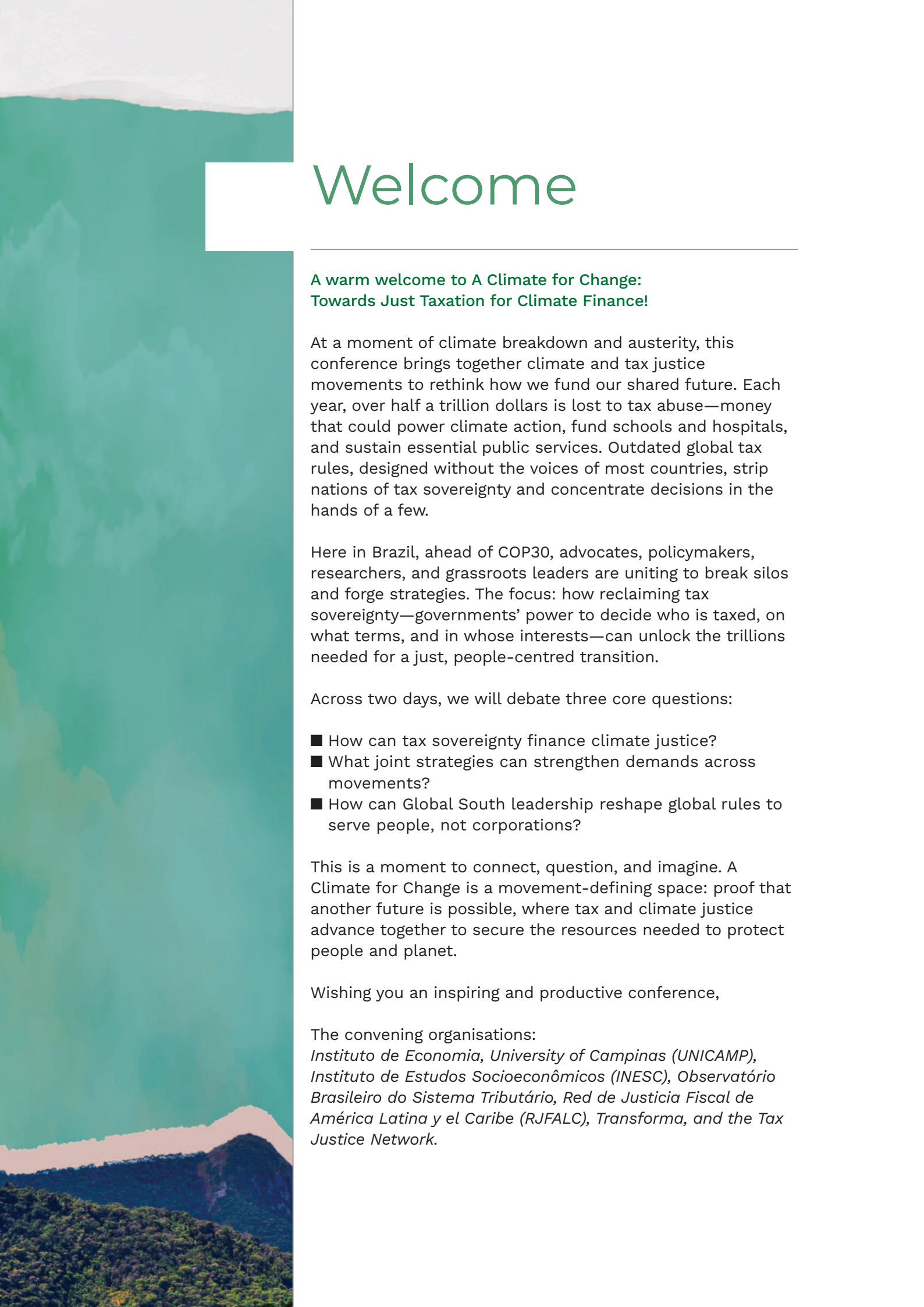

Across two days, we will debate three core questions:

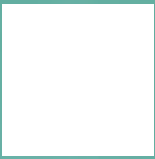
- How can tax sovereignty finance climate justice?

From False Scarcity to Just Taxation for Climate Finance

Welcome to A Climate for Change. This opening frames two days that bridge climate and tax justice: the money to fund a just transition exists, but leaks through tax abuse and unfair rules—implementing tax justice policies is essential to mobilise it. With COP30 and further negotiations toward a UN convention on international tax cooperation on the horizon, 2025 is a rare window to shift from promises to structural change. This opening will outline the programme, acknowledge our Brazilian and international partners, and set shared goals for research, policy and movement strategy—grounded in Global South leadership—to move resources at the scale required.

10:00 – 10:15 **Tax Justice and Climate Finance on the Agenda of the World March of Women**

This intervention highlights how unjust tax systems reproduce class and gender inequalities—where the poor and women shoulder disproportionate burdens while harmful activities, such as agribusiness and pesticide use, are subsidised. It frames climate finance through the lens of ecological, colonial, and gender debt, pointing to the unpaid care and environmental work that sustains economies but remains invisible. The session critiques false solutions like carbon credits that financialise nature, and instead calls for taxing the rich and curbing corporate tax abuse as preconditions for

restoring states' ability to invest. Crucially, it insists that debates on revenue must also confront the deeper question of what public spending priorities should be, ensuring resources drive adaptation, restoration, and justice.

Panel session:

The Price of Going Green: Tax Gaps in the Energy Transition

This session examines the real fiscal costs of the energy transition—and why current tax and finance arrangements leave gaps. Drawing on the Sustainable Finance Index for Latin America and the Caribbean, the panel opens with a regional diagnosis of climate-related revenues and expenditures, highlighting data gaps, budget-tagging needs and guiding principles such as progressivity, equity and environmental effectiveness. A comparative analysis then shows how extractivist, rent-dependent economies tend to entrench regressive tax mixes and weaken diversification—limiting redistribution and transition investment. A Brazilian case study of tax-favoured *debêntures incentivadas* in sanitation tests the promise of “billions-to-trillions,” finding rapid growth of the incentive alongside risks of privatisation and low additionality. A perspective from Kenya assesses whether debt-for-climate swaps can relieve intense debt-service pressure and free fiscal space, weighing competing schools of thought and community impacts. The session closes by moving from a scarcity framing to concrete measures—phasing out harmful subsidies, strengthening progressive taxation and anti-evasion tools, and advancing fairer international rules—so that transition finance is reliable, equitable and commensurate with need.

13:30 – 15:00 **Panel session: Rethinking Fiscal Paradigms: Feminist, Decolonial, and Reparative Approaches**

This panel interrogates the fiscal ideas underpinning climate finance, challenging extractivist logics and asking who benefits from the status quo. Speakers critique traditional and market-led paradigms that channel gains to elites, corporations and former colonial powers, and examine the gendered and racialised impacts of austerity. The discussion foregrounds the invisibility of care — how unpaid and underpaid care work, largely undertaken by women and marginalised communities, is devalued within budgets and climate instruments — and explores how fiscal choices reproduce colonial power relations. Drawing on feminist, decolonial and reparative traditions, the panel surfaces alternatives rooted in equity, recognition of pre-colonial and indigenous systems of resource sharing, and solidarity grounded in diverse faith and social movements. Rather than climate finance focused narrowly on emissions reduction, the session considers what a just, reparative approach would require: fiscal rules and public spending that repair ecological harm, confront inequality and debt, and build institutions capable of redressing historic and ongoing injustices.

15:30 - 17:00 **Panel Session – Common But Differentiated Responsibilities and the Role of the Ultra-Wealthy**

This panel examines how the principle of ‘Common but Differentiated Responsibilities’ (CBDR) applies to international tax cooperation in the era of climate crisis. The papers presented will unpack converging concerns: rising inequality, corporate capture, and the urgent need to find massive sums of revenue. They will elucidate the burgeoning demand to tax the super-rich, introduce global wealth taxes and redistribute resources towards vulnerable communities, while also exploring how such measures could generate transformative revenues that far exceed inadequate climate finance pledges. We will also address the need for governments to shift from regressive consumption taxes to more progressive taxation of major polluters and elites, and in so doing link transparency and measures to combat illicit financial flows with effective climate action. Finally, a case study from Colombia explores the vicious cycle between inequality and climate vulnerability, offering fiscal alternatives that would prioritise adaptation, resilience, and equity. Together, these perspectives argue that embedding CBDR in international tax rules is essential for fairness, sovereignty, and climate justice.

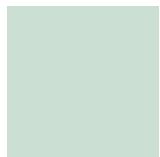

Panel Session – Fossil Fuels, Subsidies and Sovereignty: Fiscal Tools at a Crossroads

The need for climate justice drives corporate tax policy to a crossroads where the old paradigms of fossil fuel subsidies and other sectoral tax expenditures are being reconsidered while new tax instruments are being envisioned that will make carbon intensive industries pay tax in function of the negative climate externalities associated with their businesses.

The first part of the panel discussion focuses on the assessment of the old paradigm of sectoral exemption regimes and fossil fuel subsidies and how these policies stifle the mobilization of domestic resources, needed to address the climate crisis, and make countries fail their obligations to guarantee citizens' economic, social and cultural human rights. Mandatory tax disclosure frameworks like public country-by-country reporting are key instruments to reveal the extent of the current policy failure. The second part of the discussion focuses on new tax instruments and reform of international corporate tax to facilitate global climate justice. A more equitable allocation of taxing rights on profits derived from the most polluting industries like the maritime shipping industry and the oil and gas sector can allow countries in the Global South to capture a bigger part of the tax revenue and thus increase their ability to adapt to the climate crisis, caused by those same industries. A global surtax on fossil fuel profits may furthermore increase the total tax revenue raised from carbon intensive industries and fund international climate finance and development.

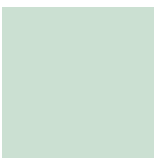

11:40 – 13:00 **Panel Session: Carbon and Beyond: Just Instruments for Pricing Pollution**

This panel explores the evolving interplay between taxation, climate policy, and sustainability, highlighting how fiscal systems are being reshaped to meet environmental needs while confronting distributional and legal challenges. The presented papers span global, national, and sectoral perspectives: from the financing of climate action through fiscal policy alignment with the Paris Agreement NDCs and the Sustainable Development Goals, to the introduction of ICMS Verde in Brazil, which redistributes revenues based on ecological performance at the municipal level. A case study of Peru examines the fiscal risks of electric-vehicle tax incentives and models more equitable alternatives for financing transport infrastructure. Finally, a comparative analysis of green taxation in extractive industries across Latin America and Iberia reveals how such measures increasingly provoke litigation and arbitration, exposing governments to fiscal and legal vulnerabilities. Together, these contributions show the potential of using taxation and fiscal policies as a tool for a just energy transition, raising critical questions about equity, sovereignty, and the balance between environmental and fiscal sustainability.

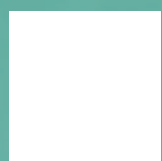

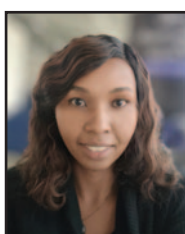
Adriana Fonteles Silva

His teaching and research themes involve International Economy, Economic Development, International Trade and Investment, Transnational Corporations, Brazilian Industrial and Technological Development, and Brazil-China Relations. He has several books, book chapters and papers in national and international journals published on his research topics.

Clara Thompson is the Global climate and tax justice lead at Greenpeace International and the author of two books on fiscal and transportation policy (“Aktionsbuch Verkehrswende”, oekom Verlag 2021; “Mobility for All”, Rosa-Luxemburg-Foundation 2024). Elisa Morgera is the Special Rapporteur on Climate Change & Human Rights for the United Nations. Elisa is a Distinguished Professor of Global Environmental Law at the University of Strathclyde, Glasgow (UK) and Adjunct Professor in International and European Union Environmental Law at the University of Eastern Finland. Previously, she worked with the United Nations Food and Agriculture Organization in Italy and the United Nations Development Programme in Barbados; and continued to collaborate with the United Nations and other international organizations as consultant and independent expert. She advised governments and civil society in Africa, Asia, Europe, Latin America, the Caribbean, and the South Pacific.



Elizabeth Cordova Alvarado

Elizabeth Córdova Alvarado is a political economist and a lawyer from Peru. She recently completed the MSc. Political Economy of Late Development at the London School of Economics and she holds a MA Political Science and Government from PUCP. She is currently developing research on fiscal justice, domestic revenue mobilization, and the political economy of energy transitions in resource-rich countries. She has authored papers on tax avoidance, elite influence, and historical limits to fiscal capacity in Peru. At TJN 2025, she presents a study on the distributional impact of electric vehicle taxation and road pricing, contributing to debates on fair and sustainable transitions in the Global South.

Florencia Lorenzo

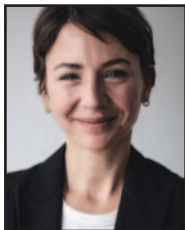

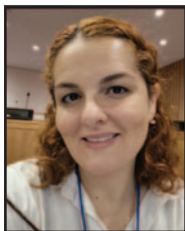
Francisco Mata Machado Tavares

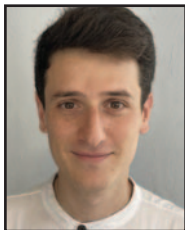
Livi Gerbase

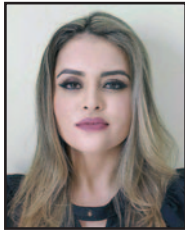

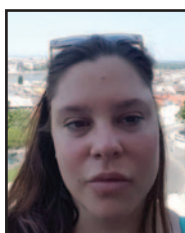
Nathalie Beghin

Rafaela Venturella De Negri

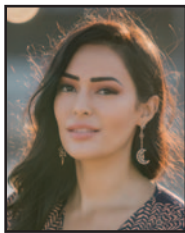
